The 2021 Australian Infrastructure Plan includes a landmark reform agenda that reflects solutions proposed by Consult Australia

NATIONAL – Consult Australia is pleased to endorse the *2021 Infrastructure Plan*, released today by Infrastructure Australia.

The 2021 Plan provides a reform pathway that reflects Consult Australia's thought leadership for improving industry productivity and innovation, including:

- our 'Model Client' Policy
- rethinking risk and contract terms to support a vibrant and sustainable industry and de-risk the professional indemnity insurance market
- our drive for a smarter pipeline of projects and a 'go slow to go fast' approach to project development
- adoption of digital solutions.

Consult Australia, the industry voice for consulting businesses in design, advisory and engineering, has been calling for urgent reform in how infrastructure projects across Australia are funded, planned, procured, and delivered. We are pleased to see that the solutions that we have put forward are included in the 2021 Plan, which lays out many of systemic challenges that have been a drag on productivity and innovation.

Nicola Grayson, Chief Executive of Consult Australia, said, "I am proud that Consult Australia's strong advocacy focus on people, pipeline, procurement, and practice have been picked up by Infrastructure Australia, the leading source of advice for governments on nationally significant infrastructure needs."

"We now need to see change in action. We need the commitment of every state and territory to realise this reform agenda, with priority given to the commercial conditions under which consulting business are operating. Poor practice is exhausting the available pool of insurance and we are seeing a rapid deterioration in affordability and quality of cover." said Grayson.

As the 2021 Plan says, there has been no better time for reform. Australians are recovering from challenges that have tested our individual and collective resilience during 2020–2021.

In addition to the still-unfolding COVID-19 pandemic, Consult Australia members are struggling to survive the professional indemnity insurance hard market, which is unlikely to recalibrate without urgent de-risking action by industry and government. In addition, our industry is facing critical skills shortages further hampered by closed international borders.

Grayson added: "The industry stands ready and more willing than ever to work with governments to ensure we can deliver quality infrastructure for all Australians."

Consult Australia will be engaging with governments across the country to assist in the implementation of the reforms set out in the 2021 Plan.
