"The guide steps through the business process for hiring overseas-qualified engineers, from understanding qualification frameworks to navigating visa requirements. It's a roadmap to help businesses of all sizes to recruit, integrate and retain international talent," Ms Banks said.

Engineers Australia Acting Chief Engineer Bernadette Foley said the guide highlights the importance of embracing global engineering talent.

"By broadening our perspective and fully recognising the value that overseas-qualified engineers bring, we can tackle an urgent skills shortage while also strengthening our professional community with fresh ideas and diverse expertise. This approach will help build a more resilient and sustainable future for Australians," Ms Foley said.

According to the 2024 Infrastructure Australia Market Capacity Report, the shortage of engineering skills remains acute, with around 25,000 engineers expected to retire by 2026. Given the time it takes to train a fully qualified engineer - approximately a decade - businesses need immediate solutions.

The business guide includes:

- myth-busting facts about overseas qualifications
- practical advice on recruitment processes, integration, and retention
- guidance on navigating Australia's complex visa and recognition frameworks.
