CONFIDENCE TO DELIVER FORWARD PIPELINE OF BUILT ENVIRONMENT PROJECTS AT RISK DUE TO CAPACITY CONSTRAINTS

Consult Australia's industry health check on COVID-19 impacts and the outlook for design, advisory, and engineering businesses

Consult Australia has today released an Industry Health Check Report for the March quarter of 2021, highlighting a strong recovery in the infrastructure and built environment sectors in comparison to last year's health check reports. The health check measures the current business impacts from the pandemic on design, advisory and engineering businesses, and the anticipated six-month outlook for the pipeline of work. Our industry is made up of 48,000 businesses and 240,000 professionals across Australia.

Findings from Consult Australia's Q1 2021 Industry Health Check show that:

- Nearly half of all businesses are currently experiencing an upturn in work. Only 11 per cent are
 experiencing a downturn in work compared to 54 per cent in our September 2020 health check
 and 66 per cent in our May 2020 health check.
- Roads, mining, residential buildings, and schools/childcare projects are driving the upturn.

The results found that the biggest issues now impacting confidence across businesses are:

- The availability and affordability of professional indemnity insurance, with the majority of businesses seeing reduced coverage and increased premiums. 90 per cent of businesses have experienced significant premium increases 11 per cent even reporting that they have experienced increases of over 100 per cent in the last 12 months.
- Workforce capacity to deliver the expected volume of work over the next six months. Skill
 shortages, exacerbated by limited access to skilled migration and a 'hot' market, is impacting the
 industry's confidence to deliver a growing pipeline of infrastructure (and related) projects, which
 in turn may impact Australia's COVID-19 recovery efforts.

Nicola Grayson, Chief Executive of Consult Australia, said:

"It is good to see many design, advisory, and engineering businesses reporting a strong upturn in work. Much of this upturn can be attributed governments' handling of the pandemic response and economic recovery efforts to date."

"With a strong recovery pipeline of projects, the focus has shifted to the capacity constraints that will impinge on industry's ability to deliver. This means looking at ways to smooth the pipeline of work and sequence the release of projects to the market. It also means urgently facing up to the diminishing availability of professional indemnity insurance and looking at how we can de-risk projects and work more collaboratively to deliver projects without costly disputes."
