## Business is booming but so are the costs and the capacity constraints

Consult Australia's health check of the design, advisory and engineering industry

Consult Australia released its latest industry health check survey results today, the latest six-monthly snapshot of sentiment among the design engineering sector that employs over 285,000 people.

Despite most businesses experiencing an upturn in work which has improved by 30% from the September 2021 survey, the lack of talent and significant cost inflation is having a negative impact on capacity and workforce wellbeing. Meanwhile the soaring cost of professional indemnity insurance is a major pain point for businesses of all sizes.

Nicola Grayson, the Chief Executive of Consult Australia, said: "Consulting businesses are experiencing significant rising costs because of the skills shortage and average increases of around 30% in the cost of professional indemnity insurance. Consult Australia continues to advocate for a more collaborative contracting environment which would take pressure of our people's mental health and de-risk project delivery. By reducing onerous contracting terms, we would also expect to see a response from insurers to moderate premium inflation, which is often the single largest cost for our members after wages."

In terms of people, the latest survey shows:

- the top business cost is salaries and wages with many businesses increasing salaries in the past 12 months
- 46% of businesses have had an increase in the voluntary turnover of staff, and it is therefore unsurprising that the cost of recruitment is also a major business cost
- work/life balance continues to be a concern for businesses, as is the mental health of their people.

### In terms of PI insurance:

- it is reported as the second highest business cost
- 79% of businesses experienced an increase in their PI insurance premium on average between 11-30%
- 60% of businesses reported a reduction in the number of insurers willing to offer cover.

Ms. Grayson said "Our industry is at breaking point. There is a record pipeline of projects and a huge talent deficit with thousands of open roles. Australia needs its professional consulting engineers, designers, and advisers more than ever. Without their work on infrastructure, whether roads or, buildings (both public and private) or, public transit, or energy networks, new investment can't be delivered, and existing infrastructure can't be maintained. We are calling on the government to become a model client, and lead by example in the way it engages with the sector so that we can create a healthy and sustainable ecosystem of productive businesses."
